


## Taxes With Tagg

As a substitute teacher on the Tagg platform, you work for yourself as an independent contractor. You choose your pay rate and hours. Because of this, taxes will work a little differently. Instead of a W-2 form that you may be used to receiving, you will get a 1099 form each year.

Unlike a salaried position, Tagg does not withhold taxes from your earnings. For this reason the government requires you to pay income tax and self-employment tax in lieu of these withholdings.

If you earn \$600 or more during the year, you will receive a 1099 tax form by January 31 from Tagg. Thanks to our payment partner, Stripe, and their work with Payable, receiving tax forms electronically has never been easier or more secure.

In early January, you will receive an email from us inviting you to create a free Payable account which will allow you to receive your 1099-MISC. In addition, it will allow you to make sure we have all of your information recorded correctly.

The 1099 form includes how much you made from your jobs using the Tagg Platform. You will use this 1099 to file your taxes.

## Estimated Taxes

---

As an independent contractor, depending on how much you think you will owe at tax time, you may be required to submit estimated quarterly payments of income and self-employment taxes. To find out if this applies to you, we suggest visiting the IRS website.
